## Rules and Regulations - PLEASE READ

I hereby apply as an entrant in the North Carolina Pageant. I certify that I will be 13 and under 19 years of age for the Teen division, 19 and under 27 years of age for the Miss division, at least 21 years of age, unmarried (single, divorced, widowed) for the Ms. Division, or at least 21 years of age for the Mrs. Division on May 1, 2011. Teen and Miss contestants must be single, with no children and never have given birth. Ms. and Mrs. contestants may be a parent. Mrs. contestants must also be married to a born male and must be residing with him. All applicants must either be a resident of the state in which she is applying for, own property, attend school or is employed in that state. Applicant must not hold a national title with any other pageant, as of April 1, 2011. She must be a U.S. citizen, in good health, not now pregnant and of good moral character. I agree that if I win and succeed to the National level, that I will not participate in any other pageants during the time I hold either the State or National title, without approval from the America's Miss Organization's (AMO) national director. I agree, and understand, that the entry fee, as well as any fee(s) or monies submitted by either myself, sponsors or advertisers are non-refundable, non-transferable and there will be absolutely NO refunds given for any reason. I further agree that I give permission to AMO and their licensees to use entrants photograph for publicity purposes in connection with the AMO without compensation to entrant or family. If any portion of the Pageant is televised either live or by video tape, contestant expressly authorizes any television station to use and show the same. I will not hold the Pageant, its directors and staff of AMO, its subsidiaries, host hotel and location where the event(s) are being held responsible for any damages, or liabilities due to accident, injury or loss of property resulting from contestant's participation in this event. The Pageant reserves the right to change the location and/or date of the Pageant should there be cause and substitute another prize of equal value, if a specified prize becomes unavailable. Scholarships awarded by institutions and sponsors provide the terms and provisions for their use by the recipients. AMO and its directors have no control over such scholarships or awards. Any cash prize may be reduced if less than 40 participants. By signature below, applicant and parents/guardian certify that they have read and understand the rules and regulations set forth herein and that the entrant meets all the eligibilities and will comply with the rules and regulations stated. Any untrue statements or failure to comply may result in a contestant's disqualification. It is further understood that if selected the state winner, contestant must represent her state making at least one public appearance a month and compete at the 2011 National Pageant; or return immediately the state crown, banner and any prizes/awards received or entitlements in connection with this title to AMO's national office.
