I hereby apply as an entrant in the Maryland Pageant. I certify that I will be 13 and under 19 years of age for the Teen division, 19 and under 27 years of age for the Miss division, at least 21 years of age, unmarried (single, divorced, widowed) for the Ms. Division, or at least 21 years of age for the Mrs. Division on June 1, 2012. Teen and Miss contestants must be single, with no children and never haven given birth. Ms. and Mrs. contestants may be a parent. Mrs. contestants must also be married to a born male and must be residing with him. I am also either a resident of the state of Maryland, own property, attend school or am employed in Maryland. I understand that I can not hold a national title with any other Pageant System as of June 1, 2012, and I am a U.S. citizen in good health, not now pregnant and of good moral character. I agree that if I win and succeed to the National level, that I will not participate in any other pageants during the time I hold either the State or National title, without approval from America's Miss Pageants Executive Director. I understand, that the entry fee, as well as any fee(s) or monies submitted by either myself, or anyone on my behalf are non-refundable, non-transferable and there will be absolutely NO refunds given for any reason. I further agree that I give permission to America's Miss Pageants and their licensees to use entrants photograph for publicity purposes in connection with the Pageant without compensation to entrant or family. If any portion of the Pageant is televised either live or by video tape, contestant expressly authorizes any television station to use and show the same. I will not hold the Pageant, its directors and staff of America's Miss Pageants, its subsidiaries, host hotel and location where the event(s) are being held responsible for any damages, or liabilities due to accident, injury or loss of property resulting from entrants' participation in this event.
